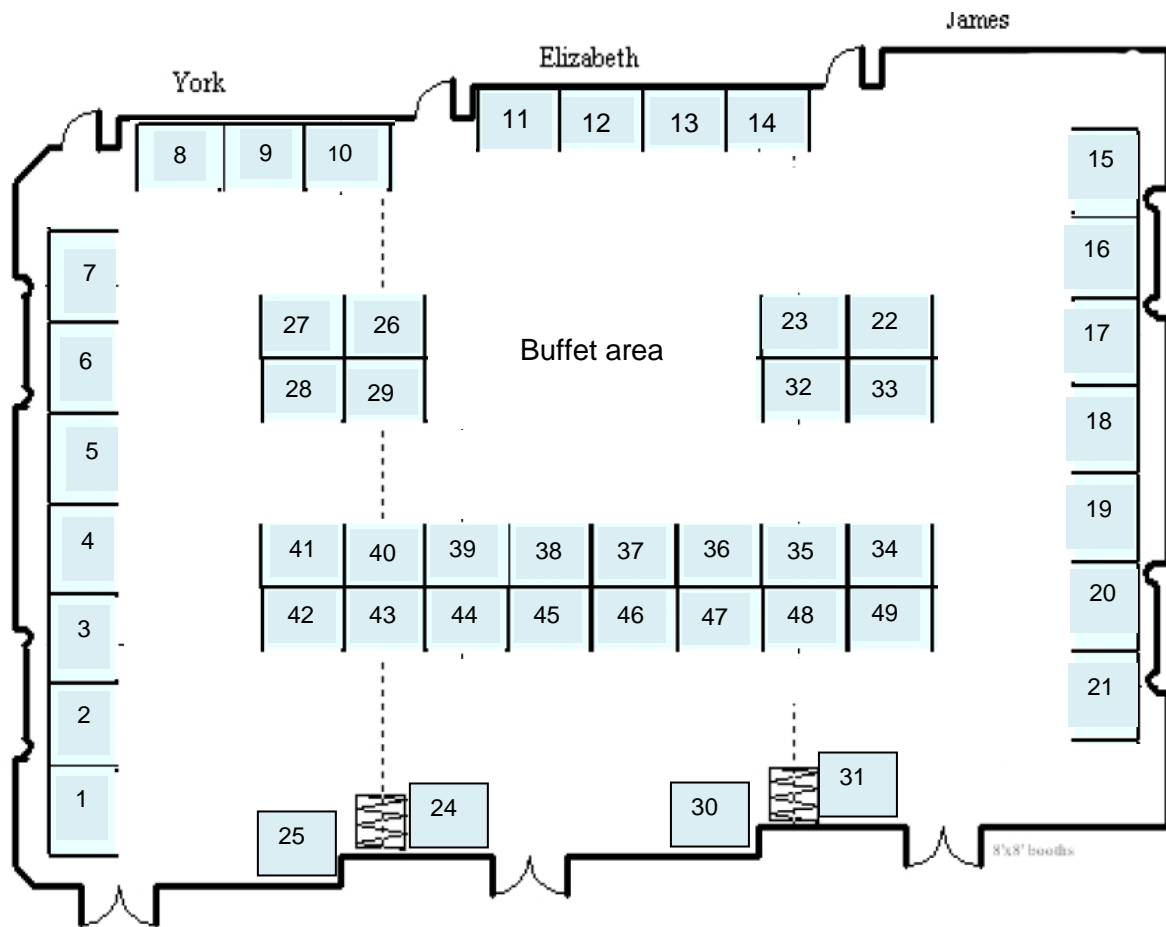

Rules for Exhibiting

1. MANAGEMENT. The word Management refers to the Tidewater Virginia Chapter of Construction Specifications Institute and their officers, employers, or agents acting for them in the management of the Building & Design Show.

2. LIABILITY. The Exhibitor agrees to protect, save and keep Management, the Holiday Inn Executive Center and the show decorating service and their representatives, employees and agents forever harmless from any and all damages or charges imposed for violation of any laws or ordinance whether occasioned by the negligence of the Exhibitor or the representatives, agents or persons acting under the authority of the Exhibitor. The Exhibitor also will indemnify and hold harmless the Management, the Holiday Inn Executive Center, and the show decorator, their members, directors, officers, agents, representatives and employees against any and all liability whatsoever arising from any or all damage to property, injury or loss caused by the Exhibitor, its agents, representatives, employees or any other such persons. Such liability will extend over the period covered by the exhibit agreement. The Management shall not be held liable in the events of delays, damage, loss or other unfavorable conditions beyond its control or if the show is canceled, postponed or relocated on account of fire, strike, government regulations, casualties, acts of God or other causes beyond the control of the Management.

3. INSURANCE. The Exhibitor is required to carry fire and theft insurance to protect his exhibit at his own expense and agrees to comply with all applicable terms, conditions, rules and regulations for the conduct of the show as outlined by the Management and the Holiday Inn Executive Center.

4. SPECIAL SERVICES. The Management will supply security services during the course of the show, however, no responsibility for Exhibitor loss of any kind is accepted by the management and all property of the Exhibitor is understood to remain in the Exhibitor's care and control. At the close of the show, the Exhibitor will be responsible to surrender exhibitor space in the same condition as when it was occupied. Exhibitor will be subject to payment of damages if necessary.

5. ARRANGEMENT OF EXHIBITS. Exhibits shall be so arranged as to not obstruct the general view nor hide the exhibits of others. Attaching materials to walls, columns, or any area outside of the booth spaces is not allowed. Management may, at its discretion, prohibit or restrict exhibits which are, in the opinion of Management, objectionable for any reason. All promotions, exhibits, activities and giveaways must adhere to generally accepted standards of good taste. All applicable federal, state and city fire laws must be strictly observed.

6. DISPUTES. Any matters not covered by the rules for exhibiting shall be subject to decision of the Management. In the event of a dispute, arising from any cause whatsoever, Management shall be the sole adjudicator, and its decision shall be final.
